# Financial Summary - November 2023

Projected Working Capital for December 2023 is \$262,189 Includes a deduction for special reserves for F.F.C. of \$41,987 Operating Position is at 92 % Income 95 % Expenses 96 %

Banked Staffing **minus \$35,552**. This time last year was minus \$38,185. Mr McLean updates the BOT regarding Banked Staffing regularly.

We currently have Term Deposits amounting to \$351,462.

Fruitvale School's Year to Date is a surplus/**deficit** of \$25,313 against original deficit budget of \$29,905.

Reviewed budget by CES and Mr McLean is surplus \$8,264.
