Mr McLean spoke in reference to his September 2024 Report.

Curriculum

An awesome Art Show - Josie Wall from TKaM was so impressed to see the students' art displayed and storytelling of Purakau. Teachers have a clear idea what we are doing with the updated curriculum. Mr McLean invited to be a member of LSRG (Learning Support Review Group) for the Minister. Term 4 is 'Under the Sea' with a trip to Goat Island over a two-day period. Organising under way for Camp 2025.

RTLB, Shirley, Bridget Kim (SWIS) and Donal met Friday morning to discuss play-based learning.

Document and Self Review

We are now officially a TKaM Mana Kura.

Kreepa and Donal to meet again re policies.

SMT and Jacqui will be attending a Strategic Planning Day early T4 hosted by Springboard Trust. Budget 2025 commencing shortly. Still have not met Amanda Douglas from ERO.

SMT attending a Trauma Awareness Conference in Brisbane 29 October to 2 November 2024. We continue to monitor our hardest to teach. Trialling a programme, LineWise.

Staffing

Employing several part time people during T4 to supplement what we are doing and what we want to achieve for our tamariki and whānau. Some of our junior TA's considering a pathway toward becoming teachers. Two teachers wishing to further their studies. Paulo Garcia, member of Parliament, walked through our school and really liked how the teachers teach. Emma Petterson, Reading Recovery, overseeing a painted mural on the G.T.T. kitchen exterior wall. Mr McLean asked to join IWS (Intensive Wrap-around Service) which oversees the allocation of monies to work with and support the region's most needy tamariki and whānau. Still pursuing SOTP for staff. Mrs White doing the bulk of learning conversations with teachers.

Generally heading the right way. Received \$200K from our new 5YA towards our maintenance issues.

Property

Difficulties with successful funding applications for court astroturf. The BOT may have to fund the \$40K balance. The tornado has been re-engineered.
